

Instructions to authors

Before submitting a manuscript for evaluation, please verify that it complies with the following indications:

1. The Monografías, Academia, Opiniones y Actitudes and Elecciones collections aim to disseminate original academic works in the field of sociology, political science and related social sciences, provided that their content contributes to a better knowledge of society, politics or social research methodology. Manuscripts outside this thematic area may be rejected without being evaluated.

2. In the case of the Academia, Opinions y Attitudes and Eleciones collections, prior to the eventual preparation of a complete manuscript for them, it is recommended to submit a **previous** and detailed draft of the same to the Editorial Board's judgment. The Editorial Board may approve or reject the project at this stage. The initial approval of a project by the Editorial Board does not necessarily presuppose its subsequent acceptance. All manuscripts, whether they are the result of a previously approved project or are submitted directly for publication, will be evaluated anonymously by the Editorial Board and the mandatory external evaluators (see editorial standards).

3 All proposals will be sent to the following email address: consejo.editorial_libros@cis.es, in Word format, specifying in the 'subject' field which collection they are directed to.

- a) The works that come from doctoral theses must specify, in a separate note, such circumstance, clarifying the institution in which it was carried out, the identity of the thesis director, as well as the composition of the panel that evaluated it and its qualification.
- b) Research resulting from doctoral theses must be presented in the format of an academic book.
- c) The rest of the original works will clarify, in a separate note, their possible relationship or connection with research projects, work in institutions or with other books-articles published by the author(s).

4. The submission of manuscripts presupposes, on the part of the authors or editors, knowledge and acceptance of these instructions, as well as the editorial standards.

5. The author of the submission or sender will be the recipient of all communications issued by the CIS Publications Department and the Editorial Board related to the proposal. He must indicate a postal address, a telephone number and an email address. This person will be responsible, in the event that there are several authors, for contacting their collaborators and providing the necessary information about them, taking responsibility for possible conflicts over authorship. If you wish to change the recipient of the communications, you must explicitly request it.

6. It will be the responsibility of the author or editor to report on the copyright situation. For the purposes of the provisions of articles 138-143 of the Intellectual Property Law regarding the actions and procedures that may be taken against whoever infringes intellectual property rights, the publication of a work that violates said rights will be the responsibility of the author. Likewise, the author is responsible to third parties for any claim that may arise in relation to the authorship of the WORK, the legality of the acquisition of the complementary materials provided (images, photographs or any material likely to generate rights) and the inherent rights, and must have from the beginning all the necessary permissions from the rights holders to incorporate them into the manuscript.

- 7. Two versions of the manuscript must be sent:
 - A version as the author or editor would like it to be published.
 - An anonymized one, that is, in which all references that allow the direct identification of the author(s) or infer their identity are deleted.
 - In any case, the CIS Publications Department will review the anonymization of the manuscripts.

8. A brief biographical note of the author(s) or editor(s) will be attached, of no more than 150 words for each person. In any case, they must include:

- The full name.

- Institutional affiliation, which will be given in descending order; that is, first the general institution (main entity) followed by the subordinate institution or institutions (departments, etc.) in the order of organic dependency they have. The city will be indicated (even if the name of the institution already includes it) and the country. The full and official name of the institution will be used.

- An e-mail address. In the event that the manuscript is finally published, the following information will also be requested:

- The highest academic degree(s) and the institution or institutions where they were obtained.

- The current position or type of hiring.
- A list with the main publications.
- The main research areas.

The CIS Publications Department reserves the right to publish a summary of said biographical note in accordance with standardized uses in the collection.

9. The works will be preceded by a brief summary of between 200 and 250 words. The summary must clearly state the purpose of the study or research (objectives); basic procedures (methods); the main findings (results), and the most relevant conclusions, as well as highlighting new and important aspects of the manuscript.

10. Regarding the **format and length** of the manuscript, the following indications must be taken into account:

- Use a single font type and size: Times New Roman 12.
- Line spacing of 1.5 space.
- Not justifying the text.
- Do not indent the beginning of paragraphs.
- All abbreviations will be described the first time they are mentioned.
- The notes will go at the foot of the page.
- The maximum length of the texts for each collection under the format conditions established in the previous sections will be the following:

Monografías - Maximum 350 pages in Word.

Academia- Maximum 450 pages in Word.

Elecciones - Maximum 450 pages in Word.

Opiniones y Actitudes - Maximum 125 pages in Word.

11. All **tables and graphs** will be numbered correctly (Roman numerals for tables and Arabic numerals for graphs) and presented one on each page, at the end of the document. They must have a concise title that allows the content of the table or graph to be understood.

Tables and graphs should be sent, if possible, in editable formats, preferably Excel, vector formats and, only if the previous ones are not

possible, in tiff or jpeg. Images must be sent separately, in tiff or jpeg format, and must have a resolution of 300 pixels/inch, with a minimum size of 10 cm wide.

In all collections, except for Opinions and Attitudes, tables, graphs, images, figures, maps, etc., **will be incorporated in black and white in the formatted** text received from the printers, in the event that it is proposed for publication.

12. All **references** in the bibliography must have their correspondence in the text, as well as any statement expressed in the text as belonging to another author must have its correspondence in the bibliography.

13. **Citations from books and articles** in the text will appear in the body of the text and not in footnotes. They will be made indicating in parentheses the author's last name in lowercase letters, followed by the year and page of the publication. Ex.: (Bourdieu, 2000, p.31). If two or more documents have the same author and year, they will be distinguished from each other with lowercase letters after the year and within the parentheses (Coté, 1985a). Documents with two authors are cited by their first surnames joined by "and" (Newton and Norris, 2000). For documents with more than two authors, the citation will be abbreviated indicating only the last name of the first author followed by "et al."

14. **Bibliographic references** will always be included at the end of the book. In those works that require it, it may be placed at the end of the chapter, following the alphabetical order of authors and according to the following established forms:

- Only references cited in the text will be included. Therefore, no additional references can be added.
- It will be <u>arranged alphabetically by the author's</u> first surname following <u>APA</u> (American Psychological Association) style.
- In the case of Spanish or Latin American authors, both surnames will be used, unless the author expressly wants to appear only with the first one. This is especially important in those authors who share a first and last name, since it is the only way to differentiate them.
- If there is more than one text by the same author, they are ordered chronologically, from the oldest to the newest. The author's name will be repeated as many times as works are cited and it will not be replaced, in any case, by a long hyphen:
 - Parella, Sònia (2003). *Mujer, inmigrante y trabajadora: la triple discriminación*. Barcelona: Anthropos.
 - Parella, Sònia (2012). «Familia transnacional y redefinición de los roles de género. El caso de la migración boliviana en España». *Papers. Revista de Sociología*, 97(3), pp. 661-684.

- If a work by one author appears cited and another, by the same author in co-authorship with others, first the work of the author alone is listed and then the publication in co-authorship. Next, the chronological order will prevail first and, in the case of works published in the same year, the alphabetical order:
 - Bettio, Francesca (2002)
 - Bettio, Francesca y Caretta, Angela (2004)
 - Bettio, Francesca y Plantenga, Janneke (2004)
 - Bettio, Francesca; Betti, Gia y Ticci, Eduardo (2019)
 - Bettio, Francesca; Mazzotta, Fabrizio y Zigante, Valentina (2019)
- If two or more works by an author published in the same year are cited, they will be distinguished by a letter:
 - Esparza, Daniel (2009a). «O Lisboa o Moscú: retos de la Presidencia checa en la UE». *Análisis del Real Instituto Elcano*, 28.
 - Esparza, Daniel (2009b). «Reflexiones sobre la Presidencia Checa en la UE: ¿La peor de toda la historia o crisis de identidad generalizada?». *Análisis del Real Instituto Elcano*, 157.
- The author's name should be developed whenever possible. If you have a compound name, you should develop only the first one and use the initial for the rest:
 - Millás, Juan, J.
- In the case of multiple authorship, all authors will be cited in the same way, up to a maximum of 20 authors. If this number is higher, the first 20 will be cited and ellipses will be added to indicate that more than one author participates in the work. 20 authors. Therefore, et is not used. to the. which will only be used in the text. Before the last mentioned author, "and" will be included.
- Bussetti, Simone; González Medina, Moneyba; Huete García, María Á. y Merinero Rodríguez, Rafael (2018). <<Los mecanismos causales de la participación social: una aplicación a la regeneración urbana>>. *Revista Española de Investigaciones Sociológicas*, 164, pp. 77-96.If a work has several authors, without specifying which is the main one, the acronym VV can be used. AA.
 - VV.AA. (2015). *Introducción a la economía y administración de empresas*. Madrid: Ediciones Pirámide.
- When a <u>republished work</u> is cited and it is considered relevant to mention the date of the first edition, this will be indicated in square brackets:
 - Maravall, J. A. (1981) [1963]. *Las comunidades de Castilla: una primera revolución modern*a. Madrid: Editorial Alliance.
- In the case of works in other languages, if there is a <u>translation</u> into Spanish, it can be included, at the end of the reference after a semicolon, with the following format:
 - Kropotkin, Pietro (1902). *Mutual Aid: A Factor of Evolution. London Heinemann*; [ed. cast.: *El apoyo mutuo: un factor de la evolución.* Bilbao: Zero, 1978].

- The names of the book collections will not be included in the reference, except in the case of working documents or reports belonging to institutions, companies, etc., in which case they can be added in order to facilitate their location.
- Translating the names of the places of publication will be avoided, always respecting the format in which they appear written in the original publication, in order to avoid variants of the same name:
 - London y no Londres, Paris y no París
- The use of DOI will be prioritized over the URL, when it exists.
- Bibliographic references always have a closing point, except if they end with a URL.
- In the case of works that do not have a date, the abbreviation will be used: (s.f.).
 - Henriques, Joao (s.f.). *Cuidando tu finca en tres pasos*. Metropolitan Publishing.
